- Dispute between brother and widow of deceased brother, partners in real estate business, regarding breach of fiduciary duty and management and control of commonly owned properties

Active arbitrator of various commercial disputes, including American Arbitration Association, FINRA and other private cases. Examples of cases arbitrated:

- Contract dispute between Illinois State Lottery and private lottery manager regarding proposed adjustments to net income goals used to compute amounts payable by manager to State for Lottery's failure to reach those goals. Determined whether manager was contractually entitled to adjustments of the nature claimed and, where appropriate, computed the amount of such adjustments. Amounts in dispute exceeded \$200 million.

- Dispute between ground lessor and ground lessee over value of land under multi-story apartment and retail building, required revaluation under ground lease. Neutral arbitrator with two other party appointed arbitrators/advocates. Unanimous decision.

- Contract dispute between insurance carrier and trucking company regarding applicability of retroactive premium adjustments provision of policy

- Court appointed special master to review over 50,000 pages of documents and report on whether discoverable in case involving environmental indemnity and indemnitor's duty to cooperate

Expert witness in cases involving real estate disputes, some with claims of legal malpractice. Testimony at trial and in depositions.
